One sachet contains not less than 5 billion live cells of *Bifidobacterium lactis* HN019.

**Ingredients:** maltodextrin, sweeteners: sorbitol and sucralose, *Bifidobacterium lactis* HN019 (ATCC SD5674), aroma; anti-caking agent: silicon dioxide; Vitamin C (L-ascorbic acid); zinc citrate; Vitamin B12 (cyanocobalamin).

**Recommended dose and administration method:** 1 sachet a day. Open the sachet and swallow the contents directly in your mouth or dissolve in a glass of water (150ml). Best taken with meals.

**Storage method:** The product contains probiotics which are sensitive to heat. It is recommended to avoid exposure to heat sources or temperature fluctuations and to store the product away from the light in a dry place preferably at a temperature between 10°C and 25°C. The minimum shelf life refers to the product correctly stored in its unopened package.

**Warnings:** Keep out of the reach of children under the age of 3 years. Do not exceed the recommended daily dose. Food supplements must not be considered as substitutes for a balanced and varied diet and a healthy lifestyle. Excessive consumption may have laxative effects. Packaged in a protective atmosphere.
